This led to one of his favorite life lessons, "If you have the right tools, you can do a good job." As Chief Financial Officer, Darryl has made a career of developing and providing the right financial tools to keep his businesses successful and growing.

Life on the farm in the cold winters of Alberta was hard. Growing up on the farm, you learned self-reliance and perseverance.
